In this issue of the Oracle, you'll find a report on past and current efforts, as well as programs and events to come. Two of those activities, the 2010 History Center (article, page 3) and our collections project (article page 4) are major efforts we can point to with great pride.

The 2010 History Center will remain open through December 18th, with two more special exhibits to come. We remain grateful to M&T Bank for embracing our vision of a local history museum in the landmark ca 1839 Dauphin Deposit Bank building. Putting a museum together in a matter of months and rotating exhibits every eight weeks has been a challenge, but a rewarding one none-the-less. We have had a wonderful time celebrating what the HSDC and its third History Center Partner, *Harris-burg150*, call "Ourstory."

Our most recent members' night at the museum was on Thursday, August 5th. Dr. Simon Bronner, author of the soon-to-be-released history, *Greater Harrisburg's Jewish Community*, joined us that evening to sign copies of his book. Dr. Bronner and we are grateful to the Jewish Community Foundation of Central Pennsylvania for their support of this project.

The HSDC collections continue to benefit from improved inventory and storage practices, as well as steps toward better climate control and accessibility both inhouse and online. As a result, we are seeing a significant increase in donations to the Society's collections from both individuals and businesses.

Recent accessions include wonderful Haldeman family letters, portraits and artifacts, donated by James Armstrong of Kalispell Montana and his sister, Mary Lou Langdell of Shelburne Vermont. Jim and Mary Lou are direct descendents of John Haldeman, who was born in Haldemanstown, now New Cumberland, in 1821, and who died in 1865, in Denver Colorado, during a pre-railroad trip through the west with his good friend, Henry McCormick. The HSDC also recently took on the storage and preservation of the negatives of all of the photos taken by Patriot-News staff from 1994, when Allied Pix ceased to provide photography services, until early in the 2000's when the paper switched to digital photography.

Although storage space is at a premium, we are thrilled to be recognized as an appropriate recipient and conservator of local history and we will move mountains, if not shelving units and furniture, to accommodate the record of our past.

Harrisburg Giants Honored at Vintage Baseball Exhibition

The Harrisburg Giants, a Negro League baseball team which played in Harrisburg, were honored after the Harrisburg Senators game on Sunday, June 6th. Former members of the Giants were introduced prior to the game and the Senators wore vintage uniforms to honor the occasion. After the game, two teams from the Mid-Atlantic Vintage Baseball Association took to the field for a three inning exhibition game using 1860's rules and period uniforms. The Historical Society of Dauphin County was announced as the host of the vintage baseball game, and Board members Calobe Jackson, Jr. and Phil Walsh staffed an information table promoting the historical society.

EVENTS PLANNED TO HONOR UNITED STATES COLLORED TROOPS

In addition to an exhibit at the 2010 History Center, numerous events are planned to celebrate the valor of the United States Colored Troops in the Civil War, including a reenactment of the Grand Review that was held for the United States Colored Troops in Harrisburg in 1865. The events will run from November 4th through November 7th, and will include the annual Pennsylvania colloquium of the Underground Railroad Society on Thursday, November 4th and an HSDC and PinnacleHealth sponsored USCT symposium at the Brady Hall Auditorium on Friday, November 5th. A white carnation dinner honoring descendants of USCT soldiers and featuring nationally known USCT speakers will be held at the Hilton on Friday Evening following the symposium. The Grand Review Procession will take place on Saturday morning November 6th followed by a Chautauqua family fair in the atrium of the Keystone Building and a special reception in the 2010 History Center. The weekend will conclude with a women's luncheon at the Hilton on Sunday November 7th honoring the contributions of African American women to the cause of freedom. There will also be presentations and conservation projects at the graves of USCT soldiers in the five county region. The conservation efforts will be undertaken as a part of the United Way Day of Caring activities. Efforts are now underway to locate and invite descendants of the men who served in the USCT.

2010 HISTORY CENTER TELLS "OURSTORY"

The **2010 History Center**, located in the old Dauphin Deposit building at 213 Market Street in Harrisburg, opened on April 17th. The center, a joint venture of the Dauphin County Historical Society and *Harrisburg150*, is part of the City of Harrisburg's *SusqueCentennial* celebration. M&T Bank has generously provided the building to house the center. History Center Curator Nancy Mendes has designed permanent exhibits featuring the history of Harrisburg with historic objects, including many that are not normally accessible to the general public, on display. Panels trace Harrisburg's history in pictures and rotating exhibits highlighting various facets of "Ourstory." The center opened with an exhibit on Harrisburg from native American habitation through 1860, followed by an exhibit spotlighting Harrisburg's "Living Legacies." Opening July 31st is "Harrisburg Comes of Age" featuring slices of life and major events in the city from the 1860s to the present day. The final rotating exhibit will honor the bravery of the United States Colored Troops who fought in the Civil War. Admission is free. Donations are gratefully accepted.

The lives and recollections of the Harrisburg area's "Living Legacies" were recently showcased at the 2010 History Center. The exhibit featured short biographies of the 150 men and women nominated by area residents and selected by a citizen's advisory board. The digital video library (DVL) interviews of the honorees were available to be accessed and viewed on a large flat screen monitor. The "Living Legacies" represent a diverse cross-section of individuals whose stories provide insight into the history of the Harrisburg area in the $20^{\rm th}$ and $21^{\rm st}$ centuries. For many, it was a nostalgic journey down memory lane. For those to whom Hurricane Agnes, shopping in downtown Harrisburg, and having a cup of coffee at Davenport's are as remote as the story of John Harris Senior being tied to the mulberry tree, it was a journey of discovery.

HARRISBURG COMES OF AGE

The 2010 History Center now features the exhibit *Harrisburg Comes of Age*, which opened on Saturday, July 31st. The exhibit traces the history of Harrisburg from the mid 1860s to the present day. Exhibit sponsors are the HARSCO Corporate Fund and The Olewine Family Foundation.

The displays take Harrisburg from 1864, when the Broad Street Market opened, the stop by Lincoln's funeral train and the Grand Review of the United States Colored Troops and continues through the construction of the Walnut Street Bridge and the burning of the old Capitol building. The displays about the 20th century feature the City Beautiful Movement, the dedication of the new Capitol, the Great Depression, the establishment of Harrisburg Area Community College, Three Mile Island, Hurricane Agnes, the rebirth of downtown, and the city watching its sons and daughters march off to World War I, World War II, Korea and Vietnam. The exhibits on the 21st century show Harrisburg reacting to September 11, 2001, watching the country going to war again in Iraq and Afghanistan, and making history with the election of the city's first female and African American mayor in 2009.

The exhibit is open through October 2nd and offers a rare and exciting opportunity to watch the evolution of the Harrisburg area as it moved from carriages to hybrid cars, music boxes to IPods, and the Spot and Davenports to "Restaurant Row."

Curator's Corner

Over 6,000 items have been described and entered into our artifact database over the past 18 months in our effort to catalog the entire contents of the Mansion. The project has been supported in part by a Collections Man-

agement Grant from the Pennsylvania Historical and Museum Commission, and while the grant period has ended, the project continues. It was notably easier and more efficient to search the collections and create labels for objects being used in the 2010 History Center. Within a few years we hope to be taking this ability for granted for all of our artifacts.

In February HSDC received a National Endowment for the Humanities Preservation Assistance Grant for the establishment of a comprehensive, site-wide, environmental monitoring program. We purchased data loggers, data logging software, and a light meter to monitor the temperature, relative humidity, and visible light in the archives, research library, and Mansion. A consultant trained staff on the installation and operation of the equipment and will meet with us again after several months of logging to evaluate the data so we can address any issues. The grant also funded the purchase of archival shelving units for the photograph archives where we have already improved the storage

WWII Medals/Insignia Belonging to S/Sgt. **Donald Alvord**

More than 25 donations have been accessioned during the first half of 2010. Transferred to HSDC from the Derry Township Historical Society is a bible that was in the Pennsylvania State Capitol when it burned in February, 1897. Inside is an inscription that says it was found by Alfred Breach in the House Committee Room. According to the House of Representatives journal for the session beginning January 1899, an Alfred Breach was paid \$30 for "making test excavation" for the new Henry Ives Cobb

An additionally noteworthy donation is a World War II dress uniform jacket and hat as well as insignia and medals that belonged to Donald Alvord of Wiconisco. Mr. Alvord graduated from

Wiconisco High School and worked in the Enola railroad yards before entering the Army in 1943. Serving in the 26th Infantry of the 1st Division, by the time the war was over he had fought in battles or campaigns in Sicily, Normandy, Northern France, the Rhineland (where he was wounded), the Ardennes, and Central Europe. He received A Purple Heart and a Bronze star among several other medals and achieved the rank of Staff Sergeant before being honorably discharged at the end of the war in September, 1945.

Dr. Bronner is a professor of American Studies and Folklore and the founding director of the Center for Pennsylvania Culture Studies at Penn State Harrisburg.

HSDC Speaker Series Becomes Third Tuesdays This Fall

The 2010-2011 Dauphin County Historical Society speaker series will move from the second Tuesday to the third Tuesday of every month, beginning in September. On September 21st, Dr. Michael Barton and Wayne Titus, HSDC member and a descendant of a Civil War soldier, will present Central Pennsylvania's Personal Civil War. Calobe Jackson, Jr. and members of the USCT Reenactor Project will present The United States Colored Troops Who Called Dauphin County Home on October 19th. The program on November 16th will feature members of the State Museum of Pennsylvania and will focus on the preservation and storage of family collections. On January 18th, Ken Wolensky of the PHMC will speak on how to conduct family research and historic structure research and preservation. Hands-on follow-up sessions in the library will be held on the two Saturdays following the program. On February 15th, the program will be tied to Dauphin County's inaugural activities celebrating Civil War 150. Please note that, due to the holidays, there will be no December program.

All programs begin at 7:00 pm in the Harris-Cameron Mansion, 219 S. Front Street, Harrisburg, and are free and open to the public. Parking is available on-site and in the Pinnacle Health physicians' lot off River Street behind the Mansion property.

In the Stacks

Since our last issue of the newsletter, the HSDC Library has had more activity than ever. Volunteers continue to computerize each and every book title for eventual listing on our website. Most of our church, cemetery, and Dauphin County court abstracts, plus many scrapbooks, atlases, and other library materials are now available in-house in an efficient, searchable PDF format. Scores of new names and necrologies have been added to the vertical surname file, which is also being re-catalogued, and for the first time hundreds of family names will be available online as well.

Many thanks to all who kindly responded to our July 2009 call for high school yearbooks from the 1950s, 1960s, and 1970s. Since then we've added some early *Rangers* from the long-since vanished Lower Paxton High School (1947-52), as well as the very first years of the Central Dauphin High School *Centralian* (1956-69) to our library. Still need lots more, especially from former Harrisburg Catholic High School and Bishop McDevitt, John Harris, and Central Dauphin East.

New additions to the stacks include *Peaceable Kingdom Lost*, a fine new history of the Paxton Boys by Boston College history professor, Kevin Kenny. And in what is a wonderful donation from the Pinnacle-Health System Library the Society also now boasts two shelves of mostly Dauphin County and Pennsylvania related medical histories, including the original standard reference for nursing, the four-volume *A History of Nursing* co-authored by Harrisburg's Lavinia Lloyd Dock (1858-1956). Lavina, as you may already know, was a younger sister of famed Harrisburg City Beautiful advocate, Mira Lloyd Dock.

Building researchers will be happy to learn that we have acquired a rare 1905 Sanborn Map of Harrisburg to add to the many other atlases in our map collection. The Sanborn Map Company was the major publisher of fire insurance atlases in North America. Their much-sought-after "bibles" documented the plans and construction materials of more than 12,000 cities and towns across the United States. The Historical Society also has a number of other fine atlases for Harrisburg, as well as Steelton, Middletown, Millersburg, and Lykens, which are useful in dating house construction in Dauphin County.

From the Archives

A very interesting booklet was recently donated to the manuscript archives. The title is "History and Evidence of the Passage of Abraham Lincoln from Harrisburg, Pa. to Washington, D. C. on the 22d and 23d of February, 1861." It was written in 1868 by Pinkerton's National Detective Agency and several editions were published in the following years. The foreword is a letter to the people of the United States from Allan Pinkerton, founder of the agency, in which he explains why the actions of his agency were revealed. Normally, silence is the rule, but historians were writing about the events of the previous years, and he thought the people should have the correct information.

The Pinkerton Detective Agency was engaged by S. M. Felton, President of the Philadelphia, Wilmington and Baltimore Railroad, to investigate the activities of the secessionists who might attempt to destroy his railroad. While involved in the investigations relative to the safety of the railroad, it was learned that a plot was in existence for the assassination of Mr. Lincoln on his passage through Baltimore to Washington, to be inaugurated as president.

The information was forwarded to Philadelphia to Hon. Norman B. Judd, a personal friend of Mr. Lincoln who was accompanying the President-elect from Springfield to Washington. Mr. Lincoln was informed, but was not convinced of the plot until the same message was received from Frederick Seward who was sent by his father and General Scott to inform him of the danger of passing through Baltimore. Changes were made immediately to the plan to travel to Harrisburg and then on to Baltimore. The President-elect's associates wanted him to leave Philadelphia that same night for Washington, but Lincoln insisted upon traveling to Harrisburg. He did so, but returned to Philadelphia and then to Washington. Telegraph lines were cut so that news of Mr. Lincoln could not be sent from Harrisburg, and the plan was carried out successfully.

Mr. Pinkerton presents evidence of the involvement of his agency with a statement from Mr. Lincoln, and letters from all those concerned including a letter from Andrew Curtin, Governor of Pennsylvania, describing Mr. Lincoln's visit to Harrisburg. Of special interest, also, is a letter from Andrew Wynne, the lineman from the American Telegraph Company, describing how he cut the wires to prevent all communication from passing over them.

The donor's father worked for Pinkerton's Detective Agency about 1947-1949 in the Buffalo office while living in Lockport, New York. Copies of the booklet were likely distributed to all Pinkerton offices. We appreciate his generosity in sending it to us.

October 7 Bus trip to Baltimore Museum of **Art and Homewood Museum**

On Thursday, October 7, the HSDC Bus Trip will take participants to the Baltimore Museum of Art for a docent led tour and Historic Homewood on the campus of Johns Hopkins University. The Baltimore Museum of Art is home to an internationally renowned collection of 19thcentury, modern, and contemporary art. Founded in 1914 with a single painting, the BMA today has 90,000 works of art—including the largest holding of works by Henri Matisse in the world. Lunch will be at Gertrude's in the museum. Then, it will be on to the Historic Homewood Museum. Homewood Museum offers visitors the chance to explore diverse interests in tremendous depth and provides an intimate look at life in early-19th-century Baltimore. The museum's collections consist of fine and decorative arts objects representative of the furnishings during the Carroll family's occupancy (1775–1825). Some works have direct affiliation with the Carroll family. The majority of the collection is American, with a strong concentration in high-quality Baltimore furniture of the period. English ceramics, silver, and furniture, as well as items of Chinese and French manufacture, are reflective of the imports available in early-19th century Baltimore. Participants will also enjoy a Madeira wine and cheese tasting while at Homewood.

This is one tour that has it all; history, art, architecture and gardens. It may be a sellout, so please register your intent early.
